Obtain a MetLife Legal Eligibility ID & Hire a Lawyer

In order to work with a client covered by MetLife Legal Plan, the attorney will need your 9-digit Eligibility ID. You should have this number ready when you meet with any attorney.

Option A: Call MetLife Legal

If you are not able to login to MetLife's legal's website: (<u>https://login.legalplans.com/login</u>) then call MetLife Legal's general number (833) 214-4172. You should be ready to provide personal information to verify your account with a MetLife representative. They can provide you with an Eligibility ID. A MetLife representative can also help you learn how to create an account (a username and password).

Option B: Check Client Portal

If you already have a MetLife Legal username and password, you can use the website (<u>https://login.legalplans.com/login</u>) to find your Eligibility ID. If you <u>do not</u> have a MetLife Legal account, you can create an account by pressing Create Account. If the system recognizes your name, email and other information, it will allow you to proceed to the site. If it does not an error message will pop up letting you know that MetLife Legal is unable to assist you and you will need to call the general number (833) 214-4172.

Here are the steps to find your Eligibility ID on the site and either do an estate plan online or hire a lawyer:
