# 2022-23 Flu Shot Requirements

#### Requirement

All ARUP employees working at or traveling to University of Utah Health facilities are required to complete one of the following by **November 16, 2022.** to better protect patients and staff from influenza:

• Receive a 2022–23 influenza vaccination at the Family Health Clinic

OR

• Receive a 2022-23 influenza vaccination from an outside health facility and submit documentation to the ARUP Family Health Clinic (email preferred).

### **Submitting Documentation**

Employees who are vaccinated by the ARUP Family Health Clinic (FHC) will not need to submit any vaccination (but may need to confirm vaccination if their name is different between ARUP's and the health records).

Employee vaccinated outside the FHC must email documentation to the clinic. The FHC manages ARUP employee compliance to the University's immunization requirements. As such, documentation of vaccination, or exemption and mask agreement must be completed and submitted to the Family Health Clinic by the given deadlines.

### Exemptions

Medical and Religious Exemption Requests must be received by the FHC by October 31<sup>st</sup>, **2022**. Requests will be sent for Americans with Disabilities Act (ADA) review, approval, and accommodation.

### **Exemption Accommodations**

In accordance with UU Health policy, those with approved exemptions are required to sign an agreement and are required to wear a mask in all University of Utah Health patient and non-patient care facilities during the 2022-23 flu season (until May 31, 2023). The UU Health standard is to mask in all areas at all times while at work. Managers must also sign this agreement for exempt employees and are responsible for monitoring masking compliance.

Employees who fail to meet these requirements by the deadline will not be allowed to work at **UU Health** sites. This may result in the employee being placed on leave, and/or receiving disciplinary action up to and including release from employment.
